

The LEGAL CHIT- CHAT By: Alan Jay Lewis, Esq.

EXEMPT PROPERTY and FAMILY ALLOWANCE under the Florida Probate Code

For those of you who MAY [at some point in the future] be involved as a <u>Beneficiary</u> of a Florida Probate Estate Administration, this article is going to discuss 2 types of "special rights/benefits/exemptions" that could EXCLUDE a portion of the Probate Estate from the Claims of Creditors of the Decedent's Probate Estate.

EXEMPT PROPERTY

In addition to Florida's constitutionally protected HOMESTEAD law, Florida Statute 732.402 entitled <u>Exempt</u> Property indicates the following:

If a DECEDENT was <u>domiciled</u> in the State of Florida at the time of his/her death, [subject to certain qualifications and exceptions], <u>the SURVIVING SPOUSE</u>, or if there is NO surviving spouse, then the CHILDREN OF THE DECEDENT shall have a right to the EXEMPT PROPERTY of the DECEDENT, as defined below:

EXEMPT PROPERTY shall consist of the following personal property:

- 1. Household furniture, furnishings and appliances in the decedent's usual place of abode up to a net value of \$20,000.00 as of the date of death of the decedent; and
- 2. <u>Two motor vehicles</u> which do not individually [as to each such motor vehicle] have a gross vehicle weight in excess of 15,000 pounds that are owned in the Decedent's name and regularly used by the Decedent or members of the Decedent's family as their personal motor vehicles; and
- 3. ALL Qualified Tuition Programs authorized by Section 529 of the Internal Revenue Code; and
- 4. ALL death benefits for teachers and school administrators as contemplated by Section 112.1915 of the Florida Statutes.

Why is the above described EXEMPT PROPERTY under the Florida Statutory law important? Because ALL "EXEMPT PROPERTY" is exempt from the claims of all creditors against the estate, except perfected security interest (such as recorded mortgages).

FAMILY ALLOWANCE:

In addition to Florida Homestead law [and other Florida Statutory entitlements], if the Decedent was domiciled in Florida at the time of his/her death, the decedent's <u>Surviving Spouse AND the Decedent's Lineal HEIRS that the Decedent was supporting or was obligated to support, are entitled to a reasonable sum of money from the Decedent's Estate for their maintenance during the administration of the Probate Estate.</u>

The Florida Family Allowance Statute defines "HEIRS" to be the Decedent's Lineal Ascendants AND the Decedent's <u>Lineal Descendants</u>. The Family Allowance shall be set by the Probate Court and shall not exceed a TOTAL of \$18,000.00. The Family Allowance set by the Court and paid to the persons entitled to receive same under Florida Statutory law may be paid as a lump sum or in periodic payments, as set by the Court.

Moreover, the Family Allowance set by the Court shall not be chargeable against any benefit or share otherwise passing to the Decedent's spouse or the Decedent's dependent Lineal Heirs, unless the Decedent's Will otherwise provides.

Even though many persons are inclined to look negatively upon Probate proceedings – sometimes there are certain benefits [SOME OF WHICH ARE NOTED ABOVE] that <u>a Beneficiary of a Decedent's Probate Administration</u> is legally entitled to receive -- if competent Legal Counsel, in representing the Beneficiary, effectively and timely follows-through with all necessary action on behalf of the Beneficiary of the Probate proceeding.

I have tried to encourage the readers of my monthly Legal Chit-Chat column to be diligent and promptly attend to their Estate Planning Needs and Goals.
